### **Progress Continues on MoPac Corridor Study**

Since two rounds of public open house meetings concluded in October and December, the Mobility Authority and TxDOT have continued to make progress on the MoPac Improvement



Project. Study and evaluation has continued on <u>four "build"</u> <u>alternatives and one "no build" alternative</u> for the corridor.

Ultimately, these options will be narrowed down to a preferred alternative based on additional public input and an analysis of the possible effects on the environment, historic properties and neighborhoods, implementation ability, right-of-way impacts and other factors. The preferred alternative will be presented to the public for review and comment in Spring 2012.

Meanwhile, outreach efforts to neighborhoods and other community stakeholders continue. A Context Sensitive Design (CSD) process is underway to shape the design of the various aesthetic features of the project. The CSD process is building on efforts completed by an aesthetics committee in 2007 and will result in the development of guidelines for items such as sound walls, bridge structures, retaining walls and landscaping. Original aesthetic committee members and other representatives from the corridor are participating in the renewed CSD effort. Additionally, meetings with neighborhood residents regarding noise mitigation and the location of sound walls will begin this summer. An open house meeting will be held on May 26, 2011 to provide updated information on various aspects of the study:

### Construction Continues on 183A Extension

The Mobility Authority continues to make progress on construction of the five-mile, 183A northern extension in Williamson County. After placing bridge deck panels in January and February, concrete

pavement is now being placed at the 183A mainlane bridges over New Hope Drive.

Construction of the new 183A mainlanes has required the temporary closure of the Scottsdale Drive crossover. Residents can still access the Block House Creek neighborhood entrance at Scottsdale Drive from the southbound 183A frontage road. # 183A Shared Use Path and South Brushy Creek Pedestrian Bridge

Construction of the 183A shared use path that runs from South Brushy Creek to FM 1431 continues, and the path is scheduled to open this summer. Design work is also underway on a bridge across South Brushy Creek that will link the 183A path with the existing Brushy Creek Regional Trail. Bridge construction is expected to begin in spring 2012.

# Mobility Authority Moving Forward with Plans to Complete Manor Expressway

Construction continues on the Manor Expressway interchange at US 183. Activities over the past month included setting beams, forming bridge decks and bridge foundation work. Concrete paving operations are also underway.



#### Design/Build Contractor Selected

In February, the Central Texas Regional Mobility Authority selected Central Texas Mobility Constructors to complete the remainder of the 6.2-mile Manor Expressway project. Central Texas Mobility Constructors is a joint venture team consisting of Webber LLC, Texas Sterling Construction Company, Michael Baker Jr., Inc. and Bridgefarmer & Associates, Inc. The team submitted a best value bid of \$207 million - well below the engineer's original estimate of more than \$300 million. The team was one of four shortlisted firms that submitted proposals. The Mobility Authority is now working to secure financing for the project. Construction is expected to be underway on the remainder of the project by summer 2011. The first 1.4-mile segment of the Manor Expressway is expected to open next year.

"Y" at Oak Hill Update

# Improvements to the "Y" at Oak Hill Coming Soon

On March 3rd, the City of Austin, Travis County, the Central Texas Regional Mobility Authority and the Texas Department of Transportation (TxDOT) announced a \$5.5 million short-term

initiative to improve traffic near the US 290 and SH 71 intersection, also known as the, "Y at Oak Hill."

In the near-term, TxDOT will implement a continuous flow intersection at the "Y", which will change how drivers make left turns. Other intersection improvements include the addition of dual turning lanes at FM 1826 and Convict Hill Road, adjusting traffic signal timing and installing median U-turns. Construction of these intersection improvements is expected to occur in 2012.

In the meantime, TxDOT and the Mobility Authority are preparing to kick-off an environmental study this summer to determine a long-term solution to the traffic problems in the corridor.

#### **HERO Program Update**

### HEROs to the Rescue on I-35

A free I-35 roadside assistance program called HERO (Highway Emergency Response Operator) is already making a difference for Central Texas Drivers. Since its launch in September 2010, HERO has provided assistance in more than 3,000 incidents. Feedback received from those assisted has been overwhelmingly positive.

HERO trucks patrol I-35 in Central Texas on weekdays between 6:00 a.m. and 8:00 p.m. Central Texas drivers are encouraged to call 974-HERO to request assistance if a HERO truck or other emergency response vehicle isn't already on the scene.
