Approve contract amendments to extend the term of existing agreements with Surveying and Mapping, LLC and The Rios Group, Inc. for general on-call subsurface utility engineering services

<u>Project Description/Background</u>: On February 23, 2022, the Mobility Authority Board approved contracts with Survey and Mapping LLC and The Rios Group, Inc. to provide on-call subsurface utility engineering (SUE) and Mobility Authority-owned utility locating services. Such approval authorized the Executive Director to negotiate and execute Work Authorizations for the SUE services contracts that cumulatively do not exceed \$300,000.00 per firm.

<u>Previous Actions & Brief History of the Program/Project</u>: These contracts are set to expire on June 30, 2025. Each firm has been utilized several times to the satisfaction of the Mobility Authority. The Engineering Department would like to extend the termination date for each contract to June 30, 2027 and include an optional two-year renewal which would extend the term of each contract to June 30, 2029, if exercised by the Executive Director.

Financing: N/A

Action requested/Staff Recommendation: Staff recommends extending contract terms with both Surveying and Mapping, LLC and The Rios Group, Inc. by two years, to expire on June 30, 2027, and include an optional two-year renewal which would extend

the term of the contract to June 30, 2029, if exercised by the Executive Director. Under this proposed extension, Surveying and Mapping, LLC and The Rios Group, Inc. will perform on-call SUE and Mobility Authority-owned utility locating services on CTRMA-operated roadways for an amount not to exceed the original contract amount of \$300,000 each.

WHEREAS, by Resolution No. 22-009 dated February 23, 2022, the Central Texas Regional Mobility Authority (Mobility Authority) Board of Directors (Board) approved contracts with Surveying and Mapping, LLC, and The Rios Group, Inc. to provide subsurface utility engineering and utility locating services to the Mobility Authority; and

WHEREAS each contract is in an amount not to exceed \$300,000 and is set to expire on June 30, 2025; and

WHEREAS only \$23,000 of the amount allocated for the Surveying and Mapping, LLC contract and \$96,000 of the amount allocated for The Rios Group, Inc. contract has been spent to date; and

WHEREAS, the Mobility Authority has an ongoing need for subsurface utility engineering and utility locating services; and

WHEREAS, the Executive Director has negotiated amendments to the contracts for subsurface utility engineering and utility locating services with Surveying and Mapping, LLC and The Rios Group, Inc. which are attached hereto as Exhibit A and Exhibit B, respectively; and

WHEREAS, the amendments extend the term of each contract to June 30, 2027, and include an optional two-year renewal which would extend the term of the contract to June 30, 2029, if exercised by the Executive Director; and

WHEREAS, the Executive Director recommends that the Board approve the proposed contract amendments with Surveying and Mapping, LLC, and The Rios Group, Inc. in the form or substantially the same form attached hereto as <u>Exhibit A</u> and <u>Exhibit B</u>.

NOW THEREFORE, BE IT RESOLVED that the Board of Directors approves the proposed amendments to the contracts with Surveying and Mapping, LLC, and The Rios Group, Inc. to provide subsurface utility engineering and utility locating services to the Mobility Authority in the form or substantially the same form as attached hereto as <u>Exhibit A</u> and <u>Exhibit B</u>; and

BE IT FURTHER RESOLVED that the Board hereby authorizes the Executive Director to exercise the two-year renewal option included in each contract at his discretion.
