APPROVING AMENDMENTS TO THE CONTRACTS WITH BGE, INC. AND IEA, INC. FOR CONSTRUCTION ENGINEERING AND INSPECTION SERVICES

WHEREAS, by Resolution No. 22-057 dated December 14, 2022, the Central Texas Regional Mobility Authority (Mobility Authority) Board of Directors (Board) approved contracts with BGE, Inc. and IEA, Inc to provide construction engineering and inspection services to the Mobility Authority; and

WHEREAS, each contract is in an amount not to exceed \$3,000,000 and is set to expire on December 31, 2025; and

WHEREAS, only \$930,000 of the amount allocated for the BGE, Inc. contract and \$288,000 of the amount allocated for the IEA, Inc. contract has been spent to date; and

WHEREAS, the Mobility Authority has an ongoing need for construction engineering and inspection services; and

WHEREAS, the Executive Director has negotiated amendments to the contracts for construction engineering and inspection services with BGE, Inc. and IEA, Inc. which are attached hereto as Exhibit A and Exhibit B, respectively; and

WHEREAS, the amendments extend the term of each contract to December 31, 2028, and include an optional two-year renewal which would extend the term of the contract to December 31, 2030, if exercised by the Executive Director; and

WHEREAS, the Executive Director recommends that the Board approve the proposed contract amendments with BGE, Inc. and IEA, Inc. in the form or substantially the same form attached hereto as Exhibit A and Exhibit B.

NOW THEREFORE, BE IT RESOLVED that the Board of Directors approves the proposed amendments to the contracts with BGE, Inc. and IEA, Inc. to provide construction engineering and inspection services to the Mobility Authority in the form or substantially the same form as attached hereto as Exhibit A and Exhibit B; and

BE IT FURTHER RESOLVED that the Board hereby authorizes the Executive Director to exercise the two-year renewal option included in each contract at his discretion.
